5.2 The duty-free café store in departures is currently being transformed into a quiet room. Chairs, a cooling fan, water cooler and a TV (on quiet setting) have been ordered. SANDS advised they will donate up to £1,000. Ability Shetland suggested sensory toys which they will provide.
